# General Information

These release notes cover all releases to the production server for the week ending July 27, 2022.

# Announcements

 **Warning:** Passing six-digit BINs can result in no match being generated when there are multiple possible matches. We recommend that you update your systems to pass eight-digit BINs as soon as possible.

## Partner Risk Controls support for BIN classification

At this time, Partner Risk Controls only support BIN classification on network tokens for Visa, Mastercard, and Discover cards. All other types of card transactions will continue to follow these rules:

- All network token transactions are treated as domestic transactions.
- All network tokens default to the domestic credit card type.
- No validation occurs on wallet load funding if an international network token is processed.
- No blocking is possible for debit or prepaid transactions because all network tokens are treated as the credit card type.
- Network tokens without BIN classification have no effect on the electronic commerce indicator (ECI) classification function.

Customers will be notified when the BIN Lookup Service recognizes network tokens for the other cards.

# Features Introduced This Week

- [RM-13566] Customers can now see new response fields related to velocity count in the REST and Simple Order APIs.
- [RM-15209] The REST API has been changed to support Field 104 Dataset ID 65 Tag 46.
- [RM-15670] If merchants invoke the Advanced Fraud Screen (AFS) explicitly, the AFS application now shows up in Similar Search.
- [RM-15695] Resellers can now enable 3-D Secure 2.0 when they board MIDs on the legacy platform.
- [RM-15991] A new merchant configuration field named Government Controlled is introduced as part of the October 2021 Visa Bi-Annual Enhancement Release.
- [RM-16049] Merchants can now use the Rule Builder to create rules for the new information code, UNV-BIN, as well as for the existing RISK-GEO information code.

## Fixed Issues

- [RM-14970] The Decision Manager Hierarchy account can now search for and export all MIDs, as expected.
- [RM-16828] Real-Time Analytics shows data again, as expected.
- [RM-16931] The credentials-on-file mandate changes for Rede is now temporarily rolled back.
