# General Information

These release notes cover all releases to the production server for the week ending August 5, 2022.

# Announcements

 **Warning:** Passing six-digit BINs can result in no match being generated when there are multiple possible matches. We recommend that you update your systems to pass eight-digit BINs as soon as possible.

## Partner Risk Controls support for BIN classification

At this time, Partner Risk Controls only support BIN classification on network tokens for Visa, Mastercard, and Discover cards. All other types of card transactions will continue to follow these rules:

- All network token transactions are treated as domestic transactions.
- All network tokens default to the domestic credit card type.
- No validation occurs on wallet load funding if an international network token is processed.
- No blocking is possible for debit or prepaid transactions because all network tokens are treated as the credit card type.
- Network tokens without BIN classification have no effect on the electronic commerce indicator (ECI) classification function.

Customers will be notified when the BIN Lookup Service recognizes network tokens for the other cards.

# Features Introduced This Week

- [RM-11503] Replay is now enabled for Decision Manager Hierarchy. Velocity rules now display velocity counts in the response.
- [RM-14601] The Transaction Search page of the Business Center is enhanced for easier scrolling, and for better visibility of the Export button.
- [RM-15411] The Transaction Details page of the Business Center now has a Payment Insights card with details about declines.
- [RM-15656] Timestamps in Audit Search now show in GMT regardless of user preferences.
- [RM-15698] In Transaction Details, PPRO transactions now reflect the current rest status and reason.
- [RM-16466] The Theme API font values are now updated to browser-recognized font family values.
- [RM-16627] The Consumer Bill Payment Service is now available for the authorization service on the Vantiv CNP processor.
- [RM-16670] Links for support and training video links are updated in the Business Center.

## Fixed Issues

- [RM-16158] After performing settlement in the Transaction Search Details page, merchants receive the receipt email with settlement details instead of authorization details, as expected.
- [RM-16604] Merchants can now see data for merchant-defined fields in the Purchase and Refund Detail report, as expected.
- [RM-16872] The Recurring Billing module in the Business Center no longer allows auto-complete of the credit card number field.
