Announcements

 **Warning:** Passing six-digit BINs can result in no match being generated when there are multiple possible matches. We recommend that you update your systems to pass eight-digit BINs as soon as possible.

Business Center Multifactor Authentication

As part of Cybersource's ongoing commitment to security, the Business Center now supports multifactor authentication. You may be required to verify your identity through a one-time PIN sent by email or SMS. After the PIN is verified, you are logged in to your account.

 **Important:** To prevent login disruptions, update your phone number and email address in your account.

Partner Risk Controls Support for BIN Classification

At this time, Partner Risk Controls support only BIN classification on network tokens for Visa, Mastercard, and Discover cards. All other types of network token transactions will continue to follow these rules:

- All other network token transactions are treated as domestic transactions.
- All other network tokens default to the domestic credit card type.
- No validation occurs on wallet load funding if an international network token is processed.
- No blocking is possible for debit or prepaid transactions because all network tokens are treated as the credit card type.
- Network tokens without BIN classification have no effect on the electronic commerce indicator (ECI) classification function.

Customers will be notified when the BIN Lookup Service recognizes other network tokens.

Features Introduced This Week

- [RM-15553] Case Search and Event Search now have a filter to allow searches for the past 30 days.
- [RM-15553] Merchants can now use the address filter to search and add countries in List Manager without requiring a postal code. US and Canada still require a postal code.
- [RM-16927] Resellers can now attach a differential fee surcharge template during merchant onboarding.
- [RM-17265] The Manage Merchants page now has a button for exporting search results in CSV format.
- [RM-17734] A Prefer Cobadged field is added to the Business Center for merchant boarding of EFTPOS merchants.
- [RM-18979] A new Profile Decision field is added to the active profile and passive profile in the Profile Rule Evaluation card on the Case Details page.
- [RM-19389] New American Express fields for Relax AVS, Relax AVS and Allow Expired Card, and Relax AVS and Allow ZIP Without Country are now available through the Template interface. The fields default to "yes" and are configurable only for Card Present Connect.
- [RM-19457] The Case Management Results export file now includes values for the TrueIP Activities, TrueIP Attributes, TrueIP Country, and TrueIP City fields.

Fixed Issues

- [RM-15553] Single sign-on merchants can now view dates, times, and time zones in the Case Search and Merchant Search pages, formatted as set in the merchant preferences.
- [RM-15553] The Decision Manager Replay Report no longer displays the total count in the Monitor, Accept, Forced Accepted, Rejects, and MAS fields.
- [RM-19474] New fields are added to the Simple Order API to comply with Article 3.15 of Visa's October 2022 Bi-annual Enhancement Release.
