- [RM-19631] Icelandic króna (ISO currency codes ISK/352) transactions are not accepted on the AIBMS, Barclays, Elavon, UATP, and Streamline processors until April 21, 2023, in preparation for a change in how the Icelandic króna handles exponents.

- [RM-20575] The Enterprise Product Configuration (EPC) API now supports Visa Rapid Onboarding as a product. The Rapid Onboarding module in the Business Center is now enabled if Visa Rapid Onboarding is enabled through the EPC API.
- [RM-20646] If there are no Merchant Administration System fields set, List Settings shows default fields for credit cards, shipping addresses, and emails.
- [RM-20805] For currency-specific merchants on EFTPOS, the merchant ID can now be fewer than 11 digits long.

# Fixed Issues

- [RM-19968] During echeck boarding, the **accountHolderName** field no longer allows commas.
- [RM-20893] Case Management users cannot create rules when the rule name contains invalid HTML tags.
