Announcements



Important: Passing six-digit BINs can result in no match being generated when there are multiple possible matches. We recommend that you update your systems to pass eight-digit BINs as soon as possible.

New Status Page

Features Introduced This Week

- [RM-18849] For Recurring Billing, subscriptions are in the **CREATED** state when the first payment has timed out and the payment is awaiting reconciliation.
- [RM-18849] Recurring Billing API calls with multiple field-level errors now include all errors in the response. When creating subscriptions or plans in the Business Center, the Business Center displays all errors as applicable.
- [RM-18849] The Subscriptions tab is removed from the Token Details page. The "Create Subscription" button is replaced with a "Manage Subscriptions" button that navigates to the Subscriptions dashboard.
- [RM-20124] Differential Fee can now accept transient tokens passed in the request and calculate the surcharge amount for merchants.
- [RM-20994] The Token Management Service API now includes network token provider IDs in the response.
- [RM-21022] A new REST API field, **cutoffDateTime**, allows for dates and times to be passed without an airport code while still appearing in the Time Of Departure field in the Case Search and Case Details pages. The new field can be used for dates and times not related to flights, such as concert dates and delivery times.

Fixed Issues

- [RM-21097] The card-present feature is available for Global Payments Australia, as expected.
