# Features Introduced This Week

- [RM-17685] The REST API field **accountType** is renamed **credentialType**.
- [RM-18341] Portfolio Management in the Business Center is updated to make Unified Checkout and Pay By Link available.
- [RM-18654] Three new fields, Application Name, Settlement Amount, and Settlement Currency, are added to the Reporting API.
- [RM-19844] New fields are available in the Transaction Request Report: Metis ID, Metis Decision, Info Codes, Response Insight Category, Response Insight Category Codes, and Network Card Type.
- [RM-20577] Users of Partner Risk Controls now see new URLs to reflect the change from Acquirer Risk Controls to Partner Risk Controls.
- [RM-20611] Customers can now add eight-digit issuer BINs to the Decision Manager Detail Report.
- [RM-20807] A new Token Management Service report displays life cycle management events that occurred on network tokens in a given merchant's vault. The report is available in CSV and XML formats.
- [RM-20823] The Organization Management Service now includes the following time zones: Australia/Brisbane, Australia/Broken Hill, Australia/Darwin, Australia/Eucla, Australia/Hobart, Australia/Lindeman, and Australia/Melbourne.
