

Announcements



Important: Passing six-digit BINs can result in no match being generated when there are multiple possible matches. We recommend that you update your systems to pass eight-digit BINs as soon as possible.

New Status Page

Features Introduced This Week

- [RM-16240] PPRO transactions now show the correct REST status and reason in Transaction Search.
- [RM-18849] For Recurring Billing, subscriptions are in the CREATED state when the first payment has timed out and the payment is awaiting reconciliation.
- [RM-18849] Recurring Billing API calls with multiple field-level errors now include all errors in the response. When users create subscriptions or plans in the Business Center, all errors are displayed as applicable.
- [RM-18849] The Subscriptions tab is removed from the Token Details page. The Create Subscription button is replaced with a Manage Subscriptions button that navigates to the Subscriptions dashboard.
- [RM-19844] New fields are available in the Transaction Request Report: Metis ID, Metis Decision, Info Codes, Response Insight Category, Response Insight Category Codes, and Network Card Type.
- [RM-20703] To comply with a Brazilian mandate, issuer responses for declines are sent to merchants.
- [RM-20714] A new Token Management Service report, the Network Token Lifecycle Management Report, provides details about the lifecycle of a token.
- [RM-20885] Token Management Service tokenization for customer-initiated transactions (with or without 3-D Secure) and merchant-initiated transactions are now available on the Rede gateway so that Rede merchants can use network tokens.
- [RM-21808] Unified Checkout and Pay By Link are now available on the Business Center's Portfolio Management pages.
- [RM-21858] Portfolio users can now create Virtual Terminal templates with a default payment configuration and apply those templates to merchants.
