# Features Introduced This Week

- [RM-19647] The Business Center's product enablement page now has Visa Platform Connect card processing fields. This update creates new merchant configurations.
- [RM-19837] Business Center users can now enter one or more TIDs when onboarding a merchant with the FDC Nashville Global processor. The assigned TID cannot be edited or deleted after the merchant is onboarded.
- [RM-19945] A Partner Risk Control default portfolio is now available to be assigned to merchants during onboarding.
- [RM-20595] The Business Center's risk dashboard has a new card and page showing reattempt filter rejection statistics.
- [RM-20806] Business Center users can now select the **trans\_ref\_no** field for EFTPOS card processing while onboarding a merchant.
- [RM-20853] The Business Center now allows a higher volume of concurrent users to log in with reduced latency.
- [RM-20894] The Business Center's Decision Manager will now validate updates to a rule, queue, custom list, or profile and display an error message if the update is invalid.
- [RM-20973] Visa Rapid Onboarding (VRO) is now available for external merchants to register for the platform. VRO now also processes merchant underwriting applications.
- [RM-21079] The Business Center now allows resellers to configure reattempt filters from the Risk Profiles page if reattempt filters are enabled.
- [RM-21705] The Business Center's Card Present Connect UI now shows updated service names.
- [RM-21881] Network Token Delete (NTD) is now enabled for Mastercard Secured Card on File (SCOF).
- [RM-22070] Merchant-initiated transactions (MITs) and card-on-file (COF) transactions are now available for certain pilot merchants who use the FDC Nashville Global processor.

# Fixed Issues

- [RM-21475] The Business Center's Partner Risk Control ADA modules now work as intended.
- [RM-21969] Customers can now use the Integration Test Tool as intended.
- [RM-21973] The Token Management Service, now allows merchants to create a subscription when they use the China UnionPay and EFTPOS processors, as intended.
- [RM-22022] Merchants using the Business Center to onboard can now access reseller payouts processor configurations.
- [RM-22137] Merchants using the Business Center can now edit custom roles as intended.
- [RM-22409] Automated invoice emails are now sending as intended.
- [RM-22612] Certain Business Center accounts are no longer allowed to issue stand-alone credits. This update eliminates fraudulent credit requests.
