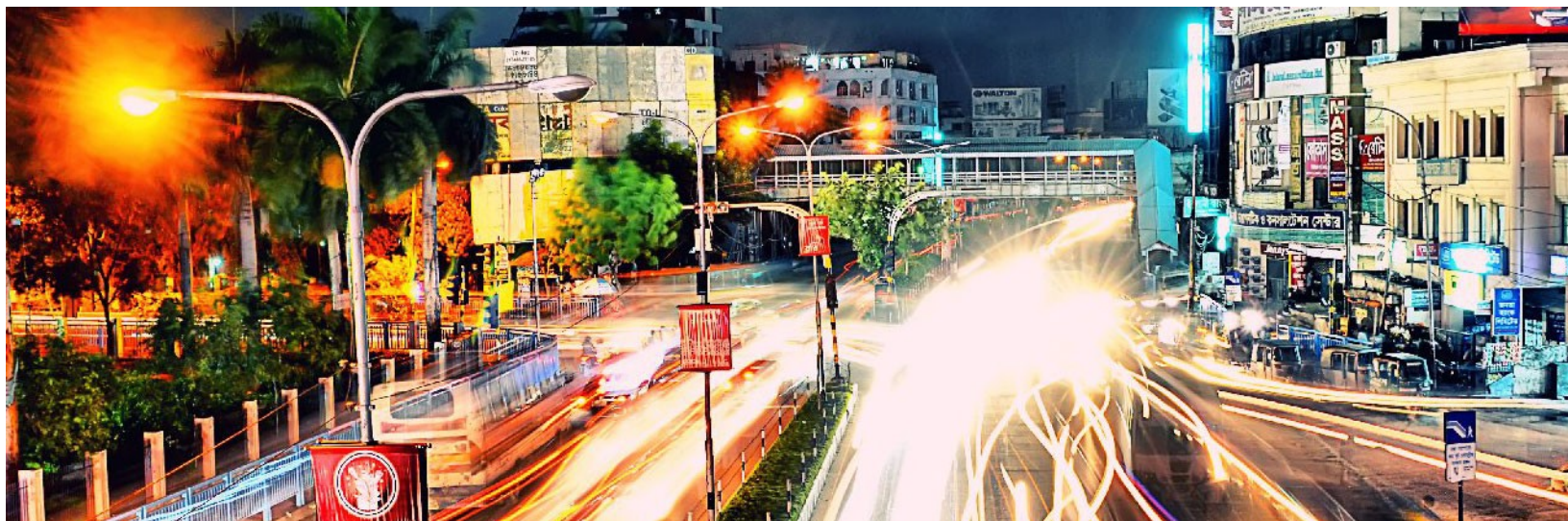

Announcements

New Reply Field for Secure Acceptance

Cybersource added a new reply field, **payment_account_reference**, to Secure Acceptance in both the Hosted Checkout and Checkout API integrations.

To avoid impact:

- Parse the reply data according to the names of the fields instead of their order in the reply. For more information on parsing reply fields, see the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* for your scripting language.
- The signature that you generate must be the same value that is included in the signature response field.
- Your error handler should use the decision field to determine the transaction result if it receives a reason code that it does not recognize.
- If your implementation expects static response fields, build the signature string dynamically instead, as specified in the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* and the sample code.

Features Introduced This Week

Decision Manager and Risk Management Enhancements

[RM-8535] In the Business Center, the Rule Order element in Decision Manager shows an Account ID field for resellers.

[RM-8535] Decision Manager resellers can now create reviewer roles and assign reviewer roles and categories to reviewer users, and can now access the extended settings page and edit its configuration.

[RM-8535] The Order Modifications Precedence section is now set to read-only for member merchants.

[RM-8471] Risk Management members can now view a user list in Queue Settings to define fraud prevention rules.

[RM-8649] Decision Manager Hierarchy parent merchants, member merchants, and non-member merchants can now view and manage cases. Risk Management members can view account ID parentage alongside the merchant ID in the merchant search filter, and the merchant search filter now supports type-ahead searches.

FDC Compass UCAF Enhancements

[RM-7542] The Mastercard cryptogram and UCAF collection indicator is updated on the FDC Compass gateway.

China Union Pay now supports 3DS 2.0

Secure Acceptance Enhancements and Updates

[RM-8471] Invoicing transactions now show up with an Invoicing client application, rather than Secure Acceptance.

[RM-8471] In Hosted Checkout, the Chinese State field now appears as a drop-down menu, and the ISO State value is used in the request. Payer Authentication requires the ISO State value for Chinese addresses.

[RM-8471] The Ethiopia Birr currency is now displayed as ETB rather than using the universal currency symbol.

[RM-8471] A new request field, **cryptocurrency_purchase**, is added.

[RM-8471] Auto Complete is enhanced on Hosted Checkout, which allows browsers to trigger Auto Complete functionality more reliably.

Issues Fixed This Week

- [RM-8617] The following fixes have been released:
 - Special characters in the **pa_merchant_name** field are now handled correctly.
 - CAVV information is now populated for Elo cards.
 - The merchant ID field now works correctly in the Payer Authentication Enroll Service.
- [RM-8158] The Virtual Terminal now defaults to enabled during merchant onboarding.
