New Reply Field for Secure Acceptance

Cybersource added a new reply field, **payment_account_reference**, to Secure Acceptance in both the Hosted Checkout and Checkout API integrations.

To avoid impact:

- Parse the reply data according to the names of the fields instead of their order in the reply. For more information on parsing reply fields, see the Secure Acceptance Checkout API Integration Guide or Secure Acceptance Hosted Checkout Integration Guide for your scripting language.
- The signature that you generate must be the same value that is included in the signature response field.
- Your error handler should use the decision field to determine the transaction result if it receives a reason code that it does not recognize.
- If your implementation expects static response fields, build the signature string dynamically instead, as specified in the Secure Acceptance Checkout API Integration Guide or Secure Acceptance Hosted Checkout Integration Guide and the sample code.
