# **General Information**

These release notes cover all releases to the production server for the week ending April 23, 2021.

## Announcements

### New Response Field for Secure Acceptance

Cybersource added a new response field, **payment\_account\_reference**, to Secure Acceptance in both the Hosted Checkout and Checkout API integrations.

To avoid impact:

- Parse the response data according to the names of the fields instead of their order in the response. For more information on parsing response fields, see the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* for your scripting language.
- The signature that you generate must be the same value that is included in the signature response field.
- Your error handler should use the decision field to determine the transaction result if it receives a reason code that it does not recognize.
- If your implementation expects static response fields, build the signature string dynamically instead, as specified in the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* and the sample code.

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

## Features Introduced This Week

- [RM-10061] The REST translator service now supports the **credit\_refund\_reason** field.
- [RM-9405] Portfolio Decision Manager Hierarchy is now supported in List Manager, allowing users to temporarily allow or deny transactions.
- [RM-9502] Password rules are now simplified and clearly displayed on the Business Center where passwords are set. Also, users receive prompts when their password does not meet a given requirement, and when their credentials are compromised.
- [RM-9563] The FDC Compass, Smart FDC, GPN, SmartPay, and FDI Global processors are updated, so the opt-out field is available within the Business Center and MAMS portal. Also, credit authorizations can now be displayed as negative values in standard transaction detail reports.
- [RM-9563] The transaction detail page now shows the network transaction ID, processor response code, and authorization code for card-on-file transactions. Also, Search now supports a filter for credit authorizations.
- [RM-9736] Payer Authentication can now be implemented as a stand-alone product during merchant boarding.

• [RM-9684] The Decision Manager Detail Report now includes previously missing details such as third-party information.
