Announcements

New Response Field for Secure Acceptance

Cybersource added a new response field, **payment_account_reference**, to Secure Acceptance in both the Hosted Checkout and Checkout API integrations.

To avoid impact:

- Parse the response data according to the names of the fields instead of their order in the response. For more information on parsing response fields, see the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* for your scripting language.
- The signature that you generate must be the same value that is included in the signature response field.
- Your error handler should use the decision field to determine the transaction result if it receives a reason code that it does not recognize.
- If your implementation expects static response fields, build the signature string dynamically instead, as specified in the *Secure Acceptance Checkout API Integration Guide* or *Secure Acceptance Hosted Checkout Integration Guide* and the sample code.

Features Introduced This Week

- [RM-10039] The Elavon gateway now parses network transaction IDs to 15 characters for transactions that are not merchant-initiated.
- [RM-10108] The Decision Manager Detail Report and Decision Manager Event Detail Report now support a new field, **Device_Behavior**, for device behavior information codes.
- [RM-10189] The authorization service for Visa Platform Connect has been migrated from Alaric to Presto.
- [RM-10221] China Union Pay support now includes 3D Secure version 2.0.
- [RM-10348] Cartes Bancaires protocol version 1.6 transactions are settled in a different batch than Cartes Bancaires protocol version 1.5 transactions.
- [RM-9456] The Token Management Service API now supports super keys that can be used for all token requestors.
- [RM-9490] The Boarding Template Management API now supports the ability to create a new boarding template and to list the existing boarding templates.
- [RM-9878] The Merchant Details page now allows users to check Payer Authentication status. Also, the Merchant Editor now supports standalone Payer Authentication.
- [RM-9891] Authorized users can now manage and validate point-to-point encryption data for terminals in the Business Center.

Fixed Issues

- [RM-10020] Google Pay users will now receive the expiration date for Discover cards if the cards are stored as primary account numbers rather than tokens.
- [RM-10062] The Business Center's Token Details page now allows users to make on-demand payments.
- [RM-10256] In the Business Center, the OAuth authorization page loads again as expected.
