Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10052] The Boarding UI is updated to use default templates within the Boarding Package and Default Profile Template API.
- [RM-10312] The transaction search advanced filters now support searches by billing phone number or shipping phone number.
- [RM-10601] Secure Acceptance has updates for the Madagasy currency exponent, and now displays the symbol "Ar" for the Madagasy Ariary. Secure Acceptance also now supports two fields, the Account Transaction Identifier and the Subsequent Authorization Stored Credentials.
- [RM-9038] The Business Center now has a user interface for both internal and external users for determining a list of sub-processors.
- [RM-9463] A new Recurring Billing Detail Report is now available in the report type dropdown menu.
