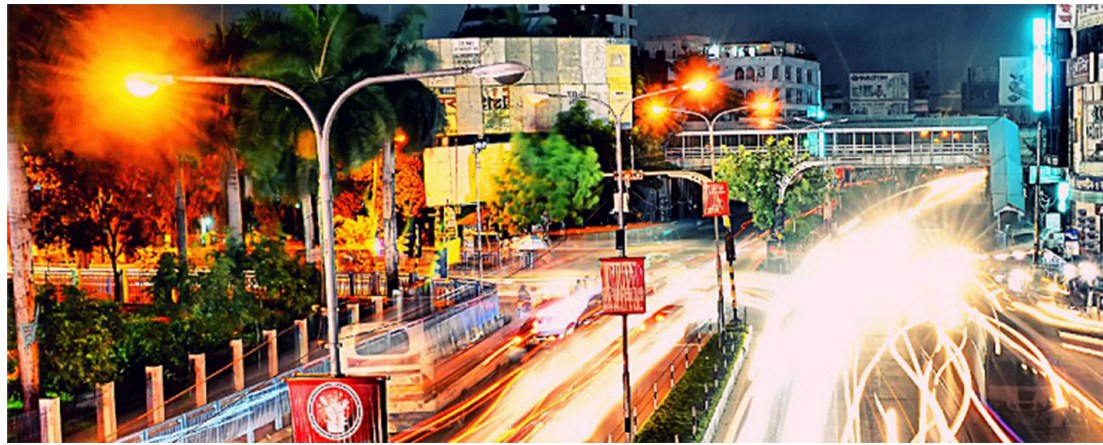

Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10064] The Instrument Identifier, Payment Instrument, and Customer APIs now support OAuth.
- [RM-10384] Key management in the Business Center has been enhanced:
 - A button for generating keys now appears on the dashboard.
 - The next five expiring keys now appear in the security key section of the dashboard.
 - The security key table is updated to clearly indicate expired keys.
 - The security key table is updated so that clicking the Key Reference entry for a key displays the Key Details page.
 - The Create Key screen now supports a consolidated view for the major key types, with linked documentation and descriptions.

Fixed Issues

- [RM-10209] On the Event Details page, the spelling of "affecting" is now corrected. Also, when the result of a Decision Manager Essentials evaluation is "Challenge", the Profile Rule Evaluation card correctly appears under "Rules affecting".
- [RM-10491] When merchants use both the China Union Pay processor and Visa Platform Connect, they no longer see transactions decline with the error, "either invalid or missing: merchant_country".
- [RM-10761] Webhooks now allow for accurate retry attempts if an initial webhook attempt fails.
