The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10618] FDI Global connections now support multi-bill per authorization for American Express and Discover.
- [RM-10711] The customer middle name and outage indicator are added to the transaction search details page and to the Transaction Subscription Service Details API for transactions other than payer authentication transactions.
- [RM-10712] Strong Customer Authentication exception indicators and authentication outage exemption indicators are added to the transaction search details page. Merchants and resellers can now view sender/recepient details for original credit transactions through the Transaction Subscription Service Details API.

Fixed Issues

- [RM-10595] Invalid validation errors no longer occur when PIN debit credit transactions for FDI Global merchants are submitted through the REST API.
- [RM-10707] The Uganda Shilling currency exponent is now set to zero (0) as expected.
- [RM-10890] The Group View permission is removed from Role Management. The permission can still be accessed through **Add Users > Customize**.
- [RM-9645] The time zone for subscription start dates is now fixed.
