### Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

### Features Introduced This Week

- [RM-10713] Response times in Decision Manager are improved for large acquirers and resellers.
- [RM-10799] On FDI Global, merchants can now send both American Express and Discover multiple bills per authorization using the I-record, and in the same format as Visa and Mastercard.
- [RM-9592] Decision Manager has enhanced scalability in special mode, for increased response times. Portfolio level Decision Manager rules have new improvements. Third-party settings for clients using Decision Manager in portfolio mode are upgraded.

- [RM-10713] An issue is fixed where the Decision Manager group page doesn't display mebers in certain conditions.
- [RM-10816] If a credit transaction is voided, the amount is not added when checking the total refund amount for the new credit transaction.
