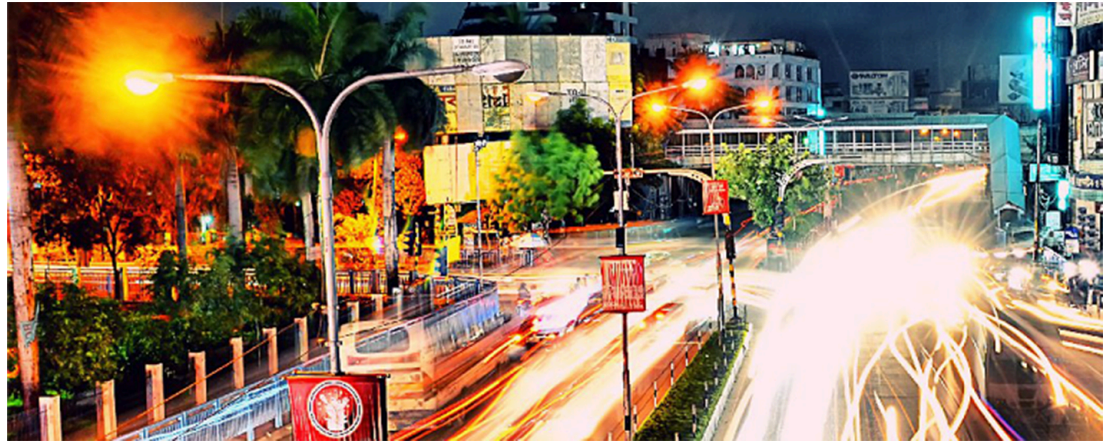

Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10535] Mastercard funding and Moneysend transactions are now supported in the REST APIs. Also, the following fields are now supported in the REST APIs: Aggregator ID, Aggregator Name, Submerchant Name, Submerchant Address, Submerchant Email, Submerchant Telephone Number, Sender First Name, Sender Last Name, and Sender Account Reference Number.
- [RM-10624] Case Management now supports a new field, POS Service Code.
- [RM-10916] Barclays merchants can now receive additional payment decline reason codes within the fields, **merchant_advice_code** and **merchant_advice_code_raw**.
- [RM-10941] When adding a new transaction node to an existing merchant, type-to-search functionality now exists to more easily select the parent node.

Fixed Issues

- [RM-10607] Merchants in CAS who are enabled for Fraud Mangement Essentials (FME) no longer appear by default to have FME enabled in Production when they do not.
- [RM-10948] Secure Customer Authentication exemptions for transactions in US dollars and Canadian dollars are no longer blocked for Paymentech merchants.
- [RM-8991] Non-ASCII characters sent on the Paymentech and FDC Compass gateways are now mapped to either spaces (" ") or question marks ("?") to ensure compatibility.
