Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10787] For credit authorizations, the processor error code 91 is remapped to error code 236: "Payment processor error. Please retry."
- [RM-10911] A differential surcharging feature is added that allows merchants to automatically add surcharge on transactions based on factors such as channel and card type, as a flat amount or a percentage of the transaction amount.
- [RM-11016] CP12 is enabled for BBVA. Also, BINs are updated for the Saudi Central Bank.
- [RM-11205] New permissions for Certification Analyst-derived permissions for various roles is added to the Business Center.
- [RM-8560] The PIN Debit Services for Visa Platform Connect gateways are updated to use the AOA platform.

Fixed Issues

- [RM-10379] Apple Pay transactions using American Express no longer fail on the Elavon gateway.
- [RM-11010] The Create Key screen no longer shows the mPOS key for merchants who do not use mPOS. Also, the key list is no longer blank for users with custom permission roles.
