Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10383] A new Manage Merchant screen in the Business Center allows for hierarchical searches.
- [RM-10416] Merchant switching is now n-level hierarchy aware and allows easy switching for complex hierarchies.
- [RM-10506] The Business Center now supports the Italian language.
- [RM-10611] The Organization Management Service now enforces hierarchy rules on status when creating or updating organization IDs.
- [RM-10612] The go-live process for merchant boarding has been improved. Merchant selection in the boarding UI now uses an elastic search. Error handling is also enhanced to show actionable steps to merchants.
- [RM-10847] Merchants can now be boarded through the Registration API. China Union Pay processor connections can also be configured through the Registration API. The new boarding UI in the Business Center now has a new card processing template for China Union Pay.
- [RM-10848] Transaction Management is changed to support PSD2/SCA compliance.
- [RM-11029] A PayByLink payment page is now added to the Business Center, and is linked in the left navigation bar.
- [RM-11152] As part of the changes for the certification environment, the Business Center now supports new permissions for the Certificate Analyst role and derived permissions for other roles.
- [RM-11246] A new differential surcharging feature lets merchants add surcharges automatically based on factors like channel and card type. These charges can be a flat amount or a percentage of the transaction amount.
- [RM-11344] The following processors are now boarded onto Visa Platform Connect: Visanet Dominicana and GT Bank.
- [RM-11456] A new service, the Installment Inquiry Service, can take merchant inputs and make a call to the processor to fetch issuer installment plan options.
- [RM-11487] The following processors are now boarded onto Visa Platform Connect: Icepay B.V. Ireland, Kuwait International Bank, FNB South Africa, Visanet Uruguay, CRDB Bank PLC, and CRDB Bank Berhad Malaysia.

• [RM-11541] The Manage Merchants screen in the Business Center now supports elastic search, and gives users the option of seeing the hierarchy structure for each node.

Fixed Issues

- [RM-11029] A bug that caused no-authorization transactions to fail in Internet Explorer is now fixed.
- [RM-11319] Merchants no longer see service fee calculations twice.
- [RM-11336] To improve performance, the Available Reports card no longer appears by default in the Business Center's home dashboard. Users can add the Available Reports card from the Edit Dashboard page.
- [RM-11541] Country lists and time zone lists now appear in the language determined by Business Center settings.
- [RM-11585] Several merchants who were erroneously enabled for credit authorization now have credit authorization disabled by default.
