## **Cybersource through VisaNet Rebranding**

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

# Features Introduced This Week

- [RM-8924] Payment Services Directive 2 merchants can now configure rules based on One Leg Out exemptions and Acquirer Country.
- [RM-11221] Merchants submitting payments through the Virtual Terminal can now add a surcharge amount, which is added to the authorization amount.
- [RM-11323] Merchants can now search for street addresses in Transaction Search.

# Fixed Issues

- [RM-10995] In transaction search results in the Business Center, the Transaction Reference Number no longer defaults to showing a green dot next to the value.
- [RM-11522] The **date\_of\_birth** request field is now passed for real-time Credilink Decision Manager calls, as expected.
- [RM-11008] Customers with an open Business Center session no longer receive 404 errors when navigating to /ebc2/oauth/authorize.
- [RM-11323] Saved searches with special characters now retrieve results correctly.
