Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10709]Merchants can now use the Klarna hosted payments pages to complete payments. Merchants can also offer Klarna Pay Now as a payment method.
- [RM-11014] SmartFDC and FDI Global are now onboarded onto the Card Processing Configuration API.
- [RM-11210] Users who are enabled for the surcharge feature can calculate the surcharge amount based on pre-configured rules by clicking the Calculate Surcharge button. Users can now see all the date fields with the timezone and date format they set up in user preferences.
- [RM-11373] Currency is now a mandatory field in surcharge fee requests. Updates to the merchant country are immediately reflected in future surcharge fee transactions.

Fixed Issues

- [RM-11532] PIN blocks on stand-alone refund requests are now passed correctly to Global Payment Exchange (GPX). Maximum PIN length capabilities are now sent to GPX. Reason code 251 is now mapped to HTTP 201, with **errorInformation.reason** set to "ALLOWABLE_PIN_RETRIES_EXCEEDED" and **errorInformation.message** set to "Allowable number of PIN entry tries exceeded".
- [RM-11546] Partners who once saw Fraud Management Essentials in the Business Center's left navigation panel no longer see the option. Partners who are not set up for Decision Manager Hierarchy or otherwise transacting at the Decision Manager level no longer see Decision Manager in the Business Center's left navigation panel.
