These release notes cover all releases to the production server for the week ending September 10, 2021.

Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10585] Reports now include surcharge amounts.
- [RM-10715] Merchants can now control Automated Direct Debit Instruction Service logging for the Bacs service, enabling the merchants to set up new direct debit instructions to the payers' banks electronically.
- [RM-10836] Resold merchants not configured on behalf of other organizations can now enable, configure, and use value-added services through the Boarding API, rather than by contacting the reseller or Cybersource.
- [RM-11019] The first eight digits of a payment card can now be used as a tracking element and a morphing element for transaction velocity. Two new fields, **eci_raw** and **pos_serviceCode**, are now included to Case Management Details, the Decision Manager Detail Report, and Rule Builder when present.
- [RM-11454] The transaction details page and transaction details API now include the surcharge amount and sign for transactions. When an authorization transaction has a surcharge amount included, the surcharge is passed along in the follow-on transaction.
- [RM-11621] The Subscription API now accepts **v-c-common-name** instead of **x-forwarded-client-cert** for validating the common name.
- [RM-11674] [SMCC] Settlement performance is improved to ensure greater settlement volume.
- [RM-11761] Visa Platform Connect Merchants no longer see transaction identifier fields in the outgoing payload.
- [RM-9459] The Virtual Terminal Configuration API can now fetch and save Virtual Terminal settings for all merchants.

Fixed Issues

- [RM-10942] The Boarding API can now board structural nodes, as expected.
- [RM-11638] Users of the merchant switch feature no longer see merchant IDs in draft or reserved status in the drop-down menu.
