Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Features Introduced This Week

- [RM-10788] The New Transaction API now includes changes for Klarna for merchant testing in the CAS environment.
- [RM-11278] The CIMB Niaga acquirer is added to CAS and Production.
- [RM-11767] The Token Management Service now supports a transient token format that includes the following fields: **track_data**, **instrument_identifier_id**, **emv_request_combined_tags**, and **emv_request_card_sequence_number**.
- [RM-11997] The following gateways are added to Visa Platform Connect: Compania Peruana de Medios de Pago, Banco General, Banco di Caribe. Also, Enhancement Planet Merchant Services UK now supports American Express.

Fixed Issues

- [RM-10896] Usernames with dashes or hyphens in the username no longer cause errors when users create a new username under their MID.
- [RM-9559] For multi-variable velocity transactions, morphing count values are now returned as expected, even when the corresponding morphing fields are not present in the request.
