Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Gateway End-Of-Life Announcement

The American Express Brighton and Omnipay Ireland gateways will reach the end of their service in November 2021. Future processing on these gateways cannot be guaranteed. If you have follow-on updates or corrections to make for transactions on either gateway, it is advised that you make the updates or corrections as soon as possible.

Features Introduced This Week

- [RM-10583] Merchants accepting payments in the Virtual Terminal can now add a surcharge amount to the authorization amount for transactions.
- [RM-10813] To support the Instant Boarding workflow, there are now three new OAuth APIs:
 - GET authorization code based on **clientId** and **merchantId** to enable a check during boarding registration to determine if authorization has been sent
 - GET client details
 - Post authorization to create and send an authorization code to the partner or reseller
- [RM-11843] The POST and GET /taps endpoints are now enabled through the Common Gateway Keeper.
- [RM-12066] New triggers are added to the GPX gateway to support pin data errors for EMV transactions.
- [RM-12128] Production transactions now comply with 2021 mandates from the Reserve Bank of India.
- [RM-12131] The following Visa Platform Connect gateways have been updated:
 - Arab African International Bank can now support American Express.
 - Republic Bank has support for new countries and currencies.
 - Kuwait International Bank no longer supports American Express.
 - First National Bank (South Africa) no longer supports American Express or Diners Club.
- [RM-12502] Merchants can now control Automated Direct Debit Instruction Service logging for the Bacs Payment Schemes service, so merchants can set up new direct debit instructions to the payers' banks electronically.
- [RM-12717] The Retrieval Reference Number is added as a new column on the Transaction Search Details page, and as a field in the Transaction Details API. Users can search for transactions using the Retrieval Reference Number.

Fixed Issues

- [RM-11337] Once an order in review status is accepted or rejected, it no longer shows on the Orders Pending Review tab.
- [RM-11921] Large organizations are no longer automatically subscribed to all available reports.
- [RM-12457] When merchants send 3D Secure v2 validation requests without a card type or card number, the transaction ID is no longer populated with the cardholder authentication verification value, preventing authentications from failing due to maximum length limits on the transaction IDs.
- [RM-12501] Specific UTF-8 characters are now handled correctly, so Decision Manager does not encounter errors when calling third-party services such as Credilink.
- [RM-12515] OmniPay Direct transactions no longer encounter spurious errors for **ics_bill**.
