Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Gateway End-Of-Life Announcement

The American Express Brighton and Omnipay Ireland gateways will reach the end of their service in November 2021. Future processing on these gateways cannot be guaranteed. If you have follow-on updates or corrections to make for transactions on either gateway, it is advised that you make the updates or corrections as soon as possible.

Features Introduced This Week

- [RM-11364] New reporting capabilities enable Account Takeover Protection (ATP) users to understand whether their rules are firing, including overall percentage as well as which rules, and how often.
- [RM-11704] The Notification Communication Engine and Near Real-Time Feed are introduced to provide notifications via webhooks, email, and SMS.
- [RM-11764] Partners can now customize themes for the Developer Center.
- [RM-12169] The following gateways are added to Visa Platform Connect: Doha Bank Qatar, Safaricom PLC, National Bank of Oman, and Commercial Bank of Ethiopia.
- [RM-12440] Global Payment Exchange now has support for Deferred Authorization Indicators, Mastercard DSRP cryptograms, the U.S. Commercial Choice program, additional token response information, American Express soft points-of-sale, and mPOS accessories and dongles with contact & contactless with or without PIN Pad as well as contact & contactless with PIN on glass.

Fixed Issues

- [RM-11630] Mastercard Identity Check transactions with a Key Transmission Block now set the Electronic Commerce Indicator to "00" as expected.
- [RM-11984] When Paypal connections time out, the ETIMEOUT error shows as expected.
- [RM-12016] Boarding merchants with card processing product configurations have improved response times.
- [RM-12456] Multiple-variable velocity rules no longer reset the count to zero when the rule name is changed.
