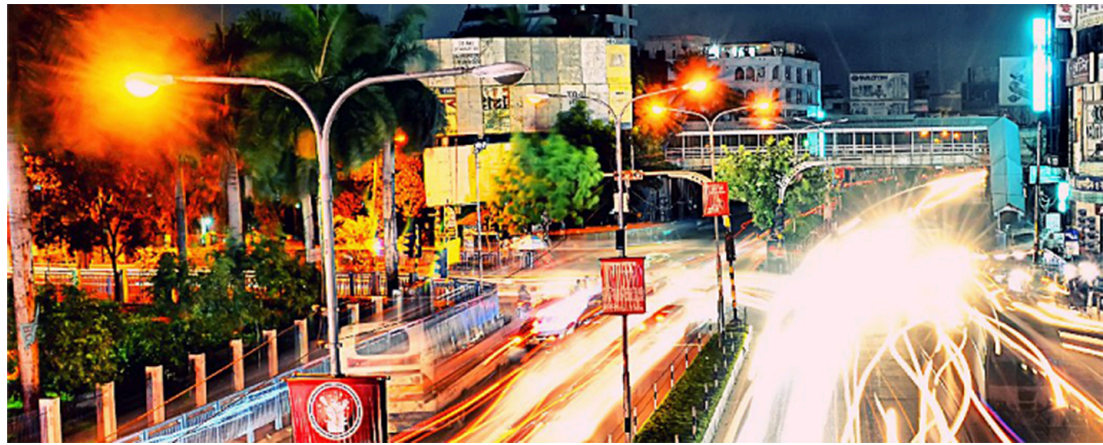

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Gateway End-Of-Life Announcement

The American Express Brighton and Omnipay Ireland gateways will reach the end of their service in November 2021. Future processing on these gateways cannot be guaranteed. If you have follow-on updates or corrections to make for transactions on either gateway, it is advised that you make the updates or corrections as soon as possible.

Features Introduced This Week

- [RM-11699] Reconciliation reporting for the Chase processor is now enabled in the Business Center, and the reports are available for viewing and downloading.
- [RM-11784] The Key Generation page now displays the serial ID in addition to the shared secret key.
- [RM-12307] The following gateways have been added to Visa Platform Connect (VPC): Peoples Bank Sri Lanka, Vietnam Prosperity Joint Stock Commercial Bank, FDMS Australia, PayGlocal India, and the Saudi British Bank. In addition, new currencies have been added to Arab Bank and ABSA Seychelles. Also, the National Commercial Bank Jamaica Limited is now updated to a hybrid gateway.
- [RM-12695] Credilink field labels are now available in the Italian language.
