Announcements

Cybersource through VisaNet Rebranding

The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Gateway End-Of-Life Announcement

The American Express Brighton and Omnipay Ireland gateways will reach the end of their service in November 2021. Future processing on these gateways cannot be guaranteed. If you have follow-on updates or corrections to make for transactions on either gateway, it is advised that you make the updates or corrections as soon as possible.

Features Introduced This Week

- [RM-11858] The Virtual Terminal's One Time Payment page now supports configuring and setting defaults for the Commerce Indicator field.
- [RM-12386] The Settlement panel now shows a warning message if the Decision Manager case related to the authorization is in Review or Reject status.
- [RM-12486] Users of the VISA Status & Incident Communication Tool can now receive SMS notifications when incidents occur.
- [RM-12807] Merchant-defined Transaction Reference Numbers are now sent in authorization requests to Moneris.
- [RM-12846] Key Refresh and Pin Translate are now available on Visa Platform Connect processors.

Fixed Issues

- [RM-12513] When a portfolio has Card Processing as the only required product in the boarding package, boarding merchants through the Business Center now goes into Live status, as expected
- [RM-12829] Soft descriptors no longer have spaces stripped in the settlement file.
- [RM-12868] Transactions on the GPX gateway no longer fail when Field 111 is included.
- [RM-12923] Response code 82 from the Streamline and Elavon gateways now maps to DCARDREFUSED instead of ESYSTEM.
