The Cybersource through VisaNet product is now called *Visa Platform Connect*.

Gateway End-Of-Life Announcement

The American Express Brighton and Omnipay Ireland gateways will reach the end of their service in November 2021. Future processing on these gateways cannot be guaranteed. If you have follow-on updates or corrections to make for transactions on either gateway, it is advised that you make the updates or corrections as soon as possible.

Internet Explorer 11 No Longer Supported

The Business Center no longer supports Internet Explorer 11. Business Center users should update their browsers.

Features Introduced This Week

- [RM-12922] Transaction Search now retains data for up to 13 months for merchants except those in India. Indian merchants will have the new data retention policy available in a follow-on release.
- [RM-12023] The Business Center no longer supports Internet Explorer 11. Business Center users should update their browsers.
- [RM-12718] The Business Center now supports Token Management Service options for not storing sensitive information for Indian merchants, to support the Payment Aggregators and Payment Gateways mandate.
